There are very few colleagues moving on this year, but we are saying goodbye to some long serving and respected colleagues. Mrs Wadeson is leaving us after two years to take up a position in another Bolton school. Mr Faulkner has led a number of students through the "Space to Bee" programme over recent years, he leaves us to pursue opportunities abroad for now. He tells us he will be back! Mrs Grady will take up her first maths teaching job after training with us this year. Mrs Newton is moving on to teach Geography in a Manchester school after 5 years service. We are also saying farewell to Mrs Prince who has worked at WHS for the last 18 years and to Mrs Sumner who has worked as a Learning Support Assistant here for 28 years. All have given incredible service to the school, and we wish them well in all they go on to do.



Return to School - September



Years 7, 10 and 11 will return on Wednesday 4th September at 8.30am. The school day will end at 2.15pm. All year groups will attend school on Thursday 5th September at 8.30am. The school day will end at 3.15pm.

Times of the School Day



Please note that the school day will now start at 8.30am - all learners should be through the gate by this time. The school day will now end at 3.15pm. Early closure on a Wednesday each week will be at 2.15pm. The bus network will support the times of our school day. Please can we request that parents and carers also support our punctuality focus when driving children to school.

Attendance

Every lesson matters for our students and so regular attendance to school is extremely important. Please continue to support this priority by avoiding making routine appointments during the school day and not booking holidays during term time. Our term dates are clearly published on our school website. Leave of absence from school will only be granted in exceptional circumstances and must be applied for in advance. A reminder that new attendance legislation takes effect for us from September which includes updated processes for the issuing of fixed penalty notices and prosecution for unauthorised absence, including holidays – please see the attached letter for more information.







The overwhelming majority of learners wear our uniform with pride, and we are grateful for parental support on this. It is our ambition to further improve standards of uniform in September. When uniform is at its best in our school, so are learning and behaviour. We wanted to be clear on the expectations before closing for the summer. Our full guidance on uniform can be found on the school website here. Key points to note regarding uniform are:

- every student must wear school shoes and not black trainers. If the footwear is made by a sports brand it will be deemed to be a trainer.
- every student must wear a tie.
- one ear piercing in each ear is permitted. Nose rings are not allowed.
- false eye lashes and nails are not allowed.
- make-up and hair colour must be natural looking and subtle.
- trousers should be a regular fit.
- skirts should sit just above the knee.
- hoodies must not be brought to school and will be confiscated at the gate.








Attendance Important Update - Changes to Education-related Penalty Notices

Information for Parents





- Penalty notices issued for offences that take place after 19 August 2024 will be charged at a new rate of £160 per parent per child. This can be paid at £80 if paid within 21 days.
- Any second penalty notice issued to the same parent for the same child within a rolling 3-year period will be issued at the rate of £160 to be paid within 28 days with no option for a discounted rate.
- The threshold at which a penalty notice must be considered is set at 10 sessions (equivalent to 5 days) of unauthorised absence within a rolling 10-school week period (1). This may include absences because of arriving late after the register closes. The 10 school weeks may span different terms or school years.
- A maximum of 2 penalty notices may be issued to a parent for the same child within a rolling 3-year period, so at the 3rd (or subsequent) offence(s) another course of action will need to be considered (such as prosecution or one of the other attendance legal interventions).
- Only penalty notices issued for absences taking place after 19 August 2024 will count towards the above thresholds.



1. A penalty notice issued for any offence that begins prior to the 19 August will be issued under the existing rules. Therefore, it will (a) be charged at £60/£120, (b) not count towards the escalation whereby a second penalty notice within 3 years is charged at a flat rate of £160 and there is a limit of 2 penalty notices within 3 years and (c) will be issued in line with the LA thresholds for the 2023-24 academic year. This is regardless of whether the penalty notice is issued before or after the 19th August.

For example, if a parent takes a pupil out of school without authorised leave of absence in term time for 10 sessions or more in July 2024 but the penalty notice is not issued until September the old rules will be followed, including being charged at the old rates of £60/£120. The penalty notice will not count towards the escalation.

2. A penalty notice issued for any offence that begins after 19 August will be issued under the new rules. Therefore, it will be (a) charged at £80/£160, (b) count towards the escalation, and (c) be issued in line with the new national threshold of 10 sessions in 10 weeks.

For example, a parent takes a pupil out of school for 5 days in the first week of the new term at the beginning of September 2024, the new rules will be followed.

Any term time holidays that are taken after the start of the 2024/25 academic year will be treated under the new legislation as the new rules apply to any offences committed from 19 August 2024, regardless of when the holiday is booked.

(1) A school week is any week in which a school meets at least once
